Consent to processing of personal data

The applicant agrees to processing of the personal data within the scope of provided personal data (hereinafter referred to as „data“) and the entry of the data in the database of the company **FL Service, s.r.o.** with registered office **Praha - Nové Město, Na poříčí 1047/26, PSČ 110 00**, registered in the Commercial Register maintained by the Municipal Court in Prague, Section C, Insert 243578.

The applicant acknowledges that his rights are guaranteed by Act no. 101/2000 Coll., On the protection of personal data, as amended, including in particular provisions § 9 a), § 11, § 12 and § 21, i. e. in particular that provision of data is voluntary, the applicant can withdraw his consent free of charge at any time at the address of the administrator, the applicant has access to personal data and right to rectify the data, block incorrect data, data disposal etc. In case of doubt regarding respecting the rights, the applicant may contact the administrator or the Office for personal data protection. Personal data are processed to offer products and services, internal statistics, to inform about marketing events as well as to send commercial communications via electronic devices according to Act No. 480/2004 Coll., about certain society information services and about changes in certain laws as amended for the period of 10 years from the grant of the consent, or until the consent is withdrawn.
